



Façade Improvement Program Guidelines and Requirements

Applications Due Friday, September 25th 2026 to PRG PO BOX 298 Punxsutawney PA 15767

Eligibility:

*The Punxsutawney Revitalization Group Façade Improvement Program is open to owners and leaseholders of **commercial** buildings (with signed approval by owners) within the borough of Punxsutawney.*

Program Scope:

The program could **reimburse 50% of the cost or up to \$1000** for approved façade improvements to the exterior “public” face of the building. Eligible improvements are exterior wall murals, painting, resurfacing (new exterior materials exclude mulch), architectural elements, awnings, windows, and signage. *Improvements already completed are not eligible. Project must not begin until approval is received. All work under this grant award must be completed and paperwork must be submitted by June 30, 2027, no extensions for any reason will be permitted.*

Requirements of the Program:

1) Application for Facade Improvement Program

A completed one-page application (attached) is required. The application packet must also include a design plan, cost estimates, materials list, and a paragraph describing the work to be completed. Applications should be submitted to PRG no later than Friday, September 25th 2026.

2) Design plan and cost estimate

Improvements must be consistent with the style and era of the building and must meet borough code regulations. A detailed design plan, which includes a paragraph detailing the scope of the work to be performed, material list, and paint samples, must be submitted for approval by PRG. A detailed estimate of the project costs must also be submitted.

3) Inspection Acceptance

If awarded, all work on the project must be completed by the date stated in the notification of the grant award. PRG will review completed work to assure standards have been met prior to reimbursement. PRG will also contact the borough’s code enforcement department to be sure the project is in compliance.

4) Reimbursement

Upon approval of completed work, submission of paid invoices and close out report, PRG will reimburse the following: **Up to 50% of approved façade improvement labor and materials with a maximum grant award of \$1000 per improvement project.**
